

## To continue your application we need to confirm your income

When you apply for a Personal Loan, Current Account or Credit Card, we may need proof of income. We may need this from you, a joint applicant or both of you. Please see the table below to understand what evidence you need to provide.

### Evidence we need

Proof of the income you've declared to Inland Revenue **for the most recently completed tax year:**

- registered as self-employed
- a Partner in a Partnership, or
- a company director who owns more than 20% of the shares of a Ltd company (if you take dividends as your income)

### What you need to do

- If you're registered for the Inland Revenue's self-assessment service, please print off your tax calculation and send it back to us with your corresponding HMRC Tax Year Overview.
- If you complete your tax return by post, please send us the SA302 letter you've received from the Inland Revenue that includes your tax calculation.  
If you have an accountant who submits your return, they can provide you with your most recently completed tax calculation or tax computation with your corresponding HMRC Tax Year Overview.
- You can also ask your accountant to complete the certificate we've included with this letter and send it back to us. They might charge you for doing this.
