UK MiFIR product governance/Professional investors and ECPs only target market - Solely for the purposes of each manufacturer's product approval process, the target market assessment in respect of the Notes has led to the conclusion that: (i) the target market for the Notes is only eligible counterparties, as defined in the FCA Handbook Conduct of Business Sourcebook (**COBS**), and professional clients, as defined in Regulation (EU) No 600/2014 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the **EUWA**) (**UK MiFIR**); and (ii) all channels for distribution of the Notes to eligible counterparties and professional clients are appropriate. - A rating of 'A1' by Moody's is described by it as follows¹: "*Obligations rated A are judged to be upper-medium grade and are subject to low credit risk*" and "*the modifier 1 indicates that the obligation ranks in the higher end of its generic assessment category*".
- A rating of 'A+' by S&P is described by it as follows²: "*An obligation rated 'A' is somewhat more susceptible to the adverse effects of changes in circumstances and economic conditions than obligations in higher-rated categories. However, the obligor's capacity to meet its financial commitments on the obligation is still strong*" and "*Ratings from 'AA' to 'CCC' may be modified by the addition of a plus (+) or minus (-) sign to show relative standing within the rating categories*".
- A rating of 'A+' by Fitch is described by it as follows³: "*'A' ratings denote expectations of low default risk. The capacity for payment of*

financial commitments is considered strong. This capacity may, nevertheless, be more vulnerable to adverse business or economic conditions than is the case for higher ratings” and “with an additional +/- for AA through CCC levels indicating relative differences of probability of default or recovery for issues”.
