Windsor Community Fund Initiative

Terms and Conditions

- These terms and conditions are set and governed by Nationwide Building Society ("Nationwide", "we", "us") for the Windsor Last Branch in Town Community Fund Initiative ("Community Fund Initiative")
- As part of the Community Fund Initiative, Nationwide will hold a Windsor Last Branch in Town Community Fund pot (the "Funds Pot"). We will make a donation of £200 into the Funds Pot each time a current account or savings account is opened with Nationwide. There will then be an opportunity to vote on which charitable scheme will benefit from the Funds Pot (See further details below).
- In order for the Nationwide to make a donation into the Funds Pot, you must:
 - 1. Be aged 18 or over
 - 2. Open a Nationwide current account or savings account between the dates of 27 February 2024 and 26 March 2024 (unless the "Donation Cap" is reached sooner)
 - 3. Have a qualifying postcode- which means that the address we hold for you indicates that your closest Nationwide Branch is the Windsor branch located 5/7 William Street, Windsor SL4 1ED.
- The Donation Cap referred to above is £10,000. When the total donations in the Funds Pot reach this amount, we will not donate any more funds into the Funds Pot.
- You will not incur any additional charges or fees as part of the Community Funds Initiative and donation into the Funds Pot will be automatic upon the opening of an eligible current or savings account, in accordance with the above.
- These terms and conditions are separate to the terms and conditions which apply to the current or savings account.
- Nationwide will only make one single donation of £200 into the Funds Pot per customer. This means that if you open multiple accounts, we will still only make one donation.
- Donations will be counted once the Donation Cap is reached or the closing date of 26 March 2024 has been reached, whichever is earlier.
- Nationwide will open a voting system to decide which of the following initiatives with The Lions Club of Windsor (Registered Charity No. 283758) ("Windsor Lions") should receive the funds equal to the amount in the Funds Pot. The charitable schemes that can be voted on are:
 - 1. Park benches
 - 2. Town mural
 - 3. Pocket garden
- Voting will be permitted by the residents of Windsor only, during the period of 27 February 2024 at 9:00am until 26
 March 2024 at 11:59pm. 'Residents' of Windsor can include existing customers and non-customers and is not limited to the customers who open a qualifying account in which resulted in Nationwide making a donation to the Funds Pot.
- Nationwide will only accept votes submitted using its physical voting boxes in Windsor branch and an online voting form (found here nationwide.co.uk/windsor)
- Total votes will be counted and verified on or shortly after 27 March 2024.
- Votes will be counted by Nationwide's partner agency 'Hatch'.
- Voting in branch is anonymous and no data is collected. Voting online will collect Postcodes but no identifying data. All
 online voting data will be deleted after use.
- If there is a tie in votes for the charitable schemes listed above Nationwide reserves the right to select the scheme from the tied winners.
- Windsor Lions will receive funds equal to the amount in the Funds Pot for the winning scheme and the winner will be announced during the week commencing 22 April in press, social media and in branch notifications.
- Nationwide has a right to discount votes if it is found to be an abuse of the process i.e if you vote multiple times for a
 particular charitable scheme.
